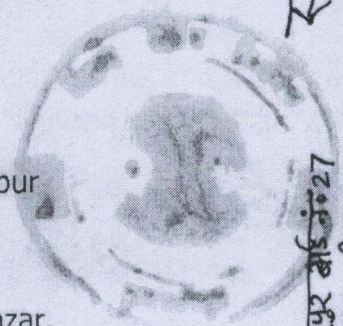

3. Nature of Deed : Public trust

4. A trust should be registered and all the necessary action for fulfilment of this aim and object should be taken as required.

(i) **Name** : It was unanimously resolved that the name of the trust will be on the name of the parents of Dr.Phulendra Bhagat and it will be known as Sandhya Chaturi Memorial Trust .In Short it will be called as S.C.Memorial Trust.

(ii) **Registered office** : The registered office of the trust will be at Sandhya Nursing Home, Bahadurpur ward no.27, Samastipur or at any other place where the trustees may decide from time to time.

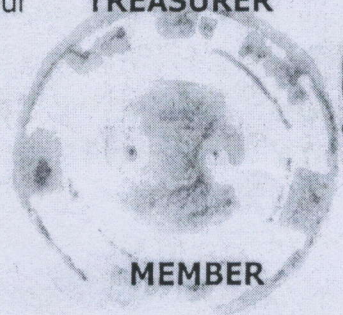

And unless with a view to and for the purpose of constituting the trust permanently as an irrevocable trust it is considered desirable that a declaration of trust is made in the manner set out here under.

And whereas donation amount to Rs 2,00,000/- have been received from the trustees for the above purposes and further funds are being and will be collected and added to the trust fund.

And whereas the Trustees hereby declare that the said fund and all further funds, donations and contribution in any shape and form and said fund from time to time and the funds, profits, income thereof and funds, Properties and securities for the time being representing the same shall be held upon the trust for the objects and purposes and subject to the power and provision herein after mentioned.

Now this declaration witness and it is hereby agreed and declared as follows:-

1. AIMS AND OBJECTIVES:

(a) To establish, construct, maintain and run Sandhya Chaturi Memorial Trust .In Short it will be called as S.C.Memorial Trust at Samastipur as a centre of constructive activities for the welfare of education all over Bihar as well as centre of educational enlightenment and promotion of cultural unity, social activities and sense of emotional and national integrity among students of the country regardless of religion, caste, creed or faith.

(b) To establish, to run and encourage basic education, to run centres for the same, early childhood education, literacy for adults with emphasis on skill developments and upgradation, higher education, technical and management education and nutrition programme for school children and women training.

(c) To establish, promote, develop, organize and maintain the same reading room information research centre and community centre to support and improve the already existing education system in the area to increase and develop awareness of the student in every walk of the life to meet the aspirations of the changing need of the society. To arrange also for training and refresher course/programme for teachers to improve their quality and knowledge.

(d) To acquire, purchase, erect, establish and equip, act or collaborate, technician, finance, administrator, central, other educational institutions anywhere in India.

2. To prepare, initiate, participate any programme of cultural, school, social, educational and related activities and to promote, encourage and assess and finance study and research on various tradition without discrimination of caste, creed, religion, sex and language.

3. To promote, assist, undertake, organize activities for feeling of equality and unity, fraternity neutrality, co-operation, self awareness, healthy public opinion, national and emotional integration among all sections of people.

4. To carry on different activities for advancement of education, art and science.

5. To run Engineering college, law college etc. to be in accordance with the rules as may from time to time be made by the trustees for the time being and also for expanding its activities by establishing other educational, technological, industrial training and professional institutions or organizations for meeting the aspirations of the changing society i.e. Bio technology, Mass communications etc.

6. To aid, assist, encourage and finance the teachers, construction, maintenance and running of residence, library, auditorium, museum, reading room, hostels, guest house, sports club, exhibition centre etc. with a view for providing facilities for social, physical, mental, cultural and spiritual development.

7. To establish, maintain or arrange grants for preventive health and social medicine centre, family planning and welfare centre, mental health centre,

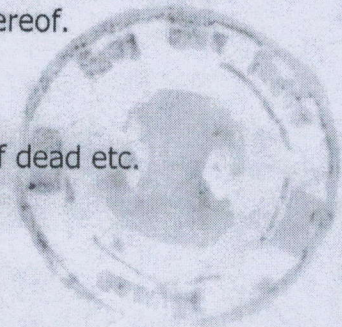

8. To establish, maintain or arrange grants to organisations, ashrams and/or institutions engaged in such activities.

To organise symposia, seminars, debates, meetings, conferences and such other activities with a view to unwilling people to appreciate correctly the message enshrined in our shastras and different scriptures and to arrange, encourage, assist and finance the printing and publication of booklets, books and literature for the spread of education and upliftment of humanity and to

distribute the same among interested persons on no profit no loss basis to improve level of awareness. To circulate periodicals, booklets, pamphlets etc and to distribute the same on no profit no loss basis.

10. To grant scholarship, awards, prizes, other allowances and concessions to students for their extra ordinary performances.

11. To do all such acts and things as may be conducive to general well being of the students for their educational, cultural, spiritual, social and economic development.

12. To establish, liaison and development mutual areas of co-operation with different organisations local, regional, state, national, international voluntary and official agencies, specialised institutional groups and individuals furtherance of aims and objectives of the trust. To act in collaboration with centre and state government and appropriate agencies, institutions, trusts and societies. In India and abroad for formulation and execution of projects, programmes, schemes of integrated rural development and impart necessary grants of funds for the aforesaid purposes.

13. To promote international understanding by maintaining relationships with other educational organisations and institutions or the governments of the foreign countries and by giving and receiving of view and ideas.

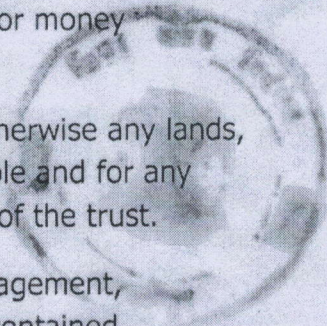
14. To raise fund and accept donations, subscription grants or money securities, properties of any kind.

15. To acquire by gift, purchase, exchange, liaison or hire otherwise any lands, building and any other property, moveable and/or immoveable and for any estate or interest for furtherance of all or any of the objects of the trust.

16. To pay all cost, charges and expenses incidental to management, administration and execution of the trust and power herein contained.

17. To raise or borrow money required for the purpose of the trust in any way as the trustee so approve of and deem on a mortgage or pledge of the trust estate or any part thereof with or without any security and at such rate of interest and on such terms the trustee shall think fit.

18. 20. To open and maintain accounts or account of the trust for keeping the moneys of the trust and to operate on the same and authorize anyone among them to operate upon them.

21. To invest dispose off transfer and overdue in such manner as the trustees deem fit and proper to do it carrying out the objects of the Trust.

22. To carry out relief work for victims of natural calamity or accidental disaster and to provide all possible services to the cause of the suffering humanity.

23. To create any reserve fund, sinking fund, insurance fund, provident fund or any other special fund whether for depreciation or for repairs improvement existence or maintenance of any of the properties or right of the trust and/ or for incompetent and wasting assets and /or for benefits of the employees and for any other purpose for which the trust deem fit expedient or to create or to maintain any such fund or funds.

24. (a) To make and enforce rules and regulation and to repeal, amend or alter the same from time to time.

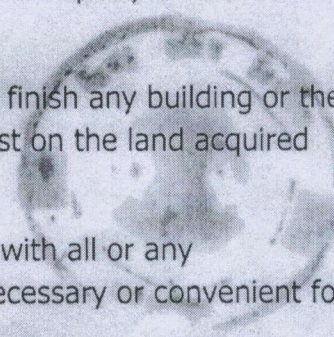
(b) To build, maintain, repair, adopt, alter, develop or finish any building or the works converted necessary for the purposes of the trust on the land acquired by way of purchase or gift or otherwise.

(c) To sell, mortgage, leave, exchange and otherwise with all or any property/movable or immovable of the trust as may necessary or convenient for the working of the trust if acquired in future.

(d) To borrow, raise or secure the payment if money in such manner if the trust shall deem proper or convenient from banks, financial institution and other for futurance of the above objectives.

(e) To open, maintain account or accounts of the trust in the post office, saving banks, State Bank of India or any scheduled bank for the purposes of keeping the money of the trust and to operate upon them.

(f) To enter into any agreement with any government or authority central, state, municipality, local body or any person whatsoever and to obtain from any rights, privileges, concession that are necessary or desirable to obtain for attainment of the above objects and to convey out, exercise and comply with such agreement, rights, providing.

(g) To undertake such other activities from time to time as shall be deemed necessary, conducive, incidental or ancillary for the attainment of the aims and objects of the trust either of its own or if the situation so demands.

(h) To appoint or employ temporarily or permanently any person that may be required for the purposes of the trust and to pay or other person salary, gratitude, provident fund, medical relief, pension and such emoluments.

(i) The income and property of the trust however derived shall be applied solely towards the promotion of the objects of the trust and no portion thereof shall be paid or transferred directly or indirectly by way of dividend, gift, loans or otherwise by way of profit to the members of the trust.

25. To negotiate and enter into contracts on behalf of the trust and very and rescind such contracts.

26. To provide for the welfare of the employees of the trust.

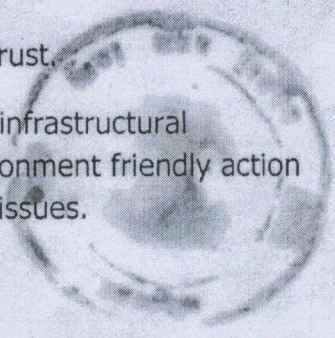
27. To help popularise execute and implement financial infrastructural operational aids and measures of pollution control environment friendly action programme and projects of the relevant environmental issues.

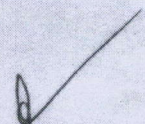
